# **Collection Subject Statement: Music**

Music materials rich in Western art music, world music, and popular music of all kinds can be found throughout the ULS. The Theodore M. Finney Music Library, located in the Music Building on the Oakland campus, houses approximately 65,000 books and music scores, 25,000 sound recordings, 1,500 microforms, 500 video recordings, and more than 150 journal titles. An even larger amount of music material is stored across the ULS in the LCSU, Hillman Library, and departmental and branch libraries. Most items can be easily shipped to any access point in the ULS.

# **Collection Purpose and Audience**

The ULS supports and develops music research, performance, and teaching through targeted acquisitions of music literature, scores, and recordings. Music collections support undergraduate music programs and graduate programs in Composition and Theory, Jazz Studies, Ethnomusicology, and Musicology, as well as the work of local and international artists and researchers unaffiliated with the university. Collections support emerging research areas in global music history.

# **Guiding Principles and Areas of Focus**

The ULS seeks to represent the whole world of music-making in its collections and to build on institutional strengths in classical music, popular song, jazz, gospel, and hip hop. General collections support archival and special collections, particularly those documenting music in Pittsburgh and jazz. Acquisition of music scores by US composers is handled primarily through Theodore Front, music scores from outside the US through Harrassowitz, and music literature through GOBI. At present, new acquisitions in music literature and scores are print preferred, with acquisition of electronic formats growing.

## **Collection Scope**

General music collections are strong in classical music, world music, and global popular music, covering musics from around the globe and from all time periods. Strengths include musics from Europe, the Americas, western Pennsylvania, and Indonesia.

Collections include scores (M), music literature (ML), music instruction texts (MT), and recordings in various formats. Music scores and recordings in all languages are collected. Historically, music literature in English and German was collected, but presently only literature in English is acquired and other languages are selectively chosen. Literature on music pedagogy is acquired only on faculty request.
