# **Collection Subject Statement: Social Work**

The Social Work collection at the University of Pittsburgh has evolved alongside the profession itself, growing from early materials focused on charity and casework to a comprehensive, interdisciplinary collection that reflects the field's expanding roles in policy, advocacy, and clinical practice. The collection is primarily located within the general collection at Hillman Library.

## **Purpose and Audience**

The Social Work collection supports course work, instruction and research from the undergraduate through the doctoral level in the School of Social Work. The collection also supports undergraduate and master's level work in child development. In addition, the collection serves to a minor degree, practicing social workers in Pittsburgh. Students, faculty, and staff needing information on social problems and policies also use the collection.

#### **Guiding Principle and Areas of Focus**

The Social Work materials are acquired utilizing approval plans, major publishers, and open access scholarly providers. The major areas of focus within the collection are administration, social policy and planning, child welfare, community organization and development, direct practice with individuals, families, and small groups, work with veterans, and international social work. Materials that support specific specializations within the school include resources on children, adolescents, and families, gerontology, home and school visitors, community economic development, community service, and child development.

#### Scope

The language of focus is English, and the primary areas of coverage are the United States and Western Europe. New acquisitions in print and electronic format are guided by review and selection of materials, with additional items acquired through requests based on curriculum, researching, and contributions to the field of Social Work. Monographs (print and electronic), databases, encyclopedias, proceedings, and conference reports are within the scope of materials collected. Books on the current social welfare systems of other countries and on comparative social welfare policies are also selected. Most books have current publication dates, older books that fall within the scope of the collection are purchased when such titles are available. Replacement items for materials beyond repair are purchased when possible. Textbooks are acquired selectively or upon request. Licensing tests are not purchased; however, books about tests are included within the collection. Films and videos are purchased at the request of faculty and graduate student researchers.
